SI. No.	The school is directed to ensure that :
1	The total number of sections of the school shall be restricted to 27 as per the number of section running during inspection, of which not more than 1/3rd sections may be used for senior secondary classes. Further the student's number in 22 sections shall be restricted to 32 (as pre dimension reported during IC) and increase of sections shall be subject to specific approval of the Board on the basis of the request of the

	school as per affiliation bye law subject to availability of class rooms of greater than 500 ft dimension.
2	The School does not have CwSN compliant toilets separately for Boys and Girls on all of the floors with enough space to negotiate the movement of the wheel chair , therefore the school shall make provision for separate toilets for CWSN, boys and girls on every floor with proper permanent signage and sufficient space for the movement of the Wheel chair , (on the cubicle indicating the floor number) as per norms of RPwD Act and Board's guidelines(https://saras.cbse.gov.in/SARAS/Circulars/Circular05_2023.pdf) and submit clearly visible video graphic compliance within 3 months on SARAS
3	The Ramp constructed by the School appears to be laid over the staircases and has a steep angle of incline. The school is required to construct the ramp / lift to access all of the upper floors as per RPWD Act-2016 and Board's guidelines (https://saras.cbse.gov.in/SARAS/Circulars/Circular05_2023.pdf) within 03 months and submit the clearly visible videographic compliance within 3 months on SARAS.
4	The School shall upgrade its Labs and Library as per Board's SoPs and submit compliance within 3 months.
5	The school shall conduct training of its teachers with CoE NOIDA within 3 months and submit the compliance

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/-every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be

The approval of the Board as mentioned above, is subject to the following conditions:-

- The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
- The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
- 3. The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
- 4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates.
- 5. The school shall renew mandatory certificates from time to time.
- 6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
- Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.

- 8. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
- 9. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.
